

Call for Expression of Interest (EOI)

Development and Management Proposal for the Gohagoda Final Solid Waste Dumping Site

(Owned by Kandy Municipal Council)

The **Kandy Municipal Council (KMC)** invites Expressions of Interest (EOIs) from qualified and interested parties for the development, control, and sustainable management of the **Gohagoda Final Solid Waste Dumping Site**. Proposals should focus on creating an environmentally friendly and health-conscious waste management solution and demonstrate the advantages and comprehensive outcomes of the proposed project.

Current Situation

- **Total Land Area:** 30 acres (approximately 3 to 5 acres available for the proposed project)
 - **Daily Waste Collection:** 80–100 metric tons.
 - **Waste Composition:** Approximately 70% organic and 30% non-organic waste.
 - **Existing Landfills:** There are currently three (03) landfills on-site that have been used for waste dumping for over 50 years. The accumulated waste in these landfills can be utilized as a potential resource for the proposed project.
 - **Utilities:** The site currently has a 3-phase CEB power connection and a water supply from the National Water Board. Additional natural water resources may be obtained from the nearby Mahaweli River.
 - Additionally, the city's toilet wastewater treatment system processes approximately 5 cubic meters of sludge per day, which can be effectively utilized for other related projects.”

Objective

The objective of the Kandy Municipal Council is to implement a **sustainable, environmentally responsible, and economically viable** plan for the **improvement, control, and long-term management** of the Gohagoda Final Dumping Site. The development must comply with all applicable **government rules and regulations**.

Invitation for Proposals

Proposals and concept submissions are expected to cover, but are not limited to, the following key aspects:

1. **Technical approach** to site development, control, and waste management.
2. **Environmental protection** and pollution control measures.
3. **Financial and operational feasibility** of the proposed solution.
4. **Legal and procedural compliance** with national and local regulations.
5. **Investment opportunities** for both Sri Lankan and foreign investors (note: foreign investors must operate through a registered local subsidiary).

Terms and Conditions

- All submitted proposals will be reviewed and evaluated by a **specialized technical evaluation committee** appointed by the KMC.
- Proposals must include:
 1. **Project duration and implementation schedule**
 2. **Handover process and operational plan**
 3. **Benefits and value additions to the Government and KMC**
